Resident's Rights:

Money and Property:

Each resident has the right to manage personal finances, or if he or she so chooses, to designate another party to manage them for him or her. We ask that all residents bring limited funds into the care center as we have many other residents, visitors, and staff. Funds are not usually needed in the care center as the care center pays for most outings and the beauticians will take payment via a billing method. Funds can also be deposited into a resident trust account, which we strongly encourage.

We also have the option to have payments made through an ACH system, rather than having to mail/write out checks. Please contact Teresa Selken if you are interested in this option.
