The right to request, refuse and/or discontinue treatment, to participate in or refuse to participate in experimental research, and to formulate an advance directive.

Attention Volunteers:

Volunteers for activities will start back up on June 21st in the facility. Volunteers will be screened by the activity director when they arrive. The activity director will determine if the volunteer has been vaccinated or not.

If the volunteer has been vaccinated, no covid test will be needed. Please bring your vaccination card with you for us to make a copy of.

If the volunteer is unvaccinated, they will need to be tested for Covid-19 right after screening is complete. Please arrive 15 minutes before the activity for the test to be completed. If a test is positive, the volunteer will need to leave the facility immediately.

All Volunteers will need to wear a face mask and adhere to the core principles of Covid-19 prevention.

During the activity, the activity director will keep a log of residents that attend the activity. If there are any staff or residents that are unvaccinated in the activity, the activity director will offer a face mask to those residents. If the resident refuses to wear the mask the activity director will keep a log of this.
